

# Fossil Finance Violations: Tracking Fossil Fuel Projects that violate commitments to end international public finance for fossil fuels

This tracker documents known approved or pending fossil fuel projects that are in violation of the Clean Energy Transition Partnership (commonly referred to as the Glasgow Statement) and near identical G7 commitment to end international public finance for fossil fuels by the end of 2022.
